What we collect

Security and Storage of Information

Retention of information

OT Neuro Ltd adheres to guidelines set by its professional bodies with regard to the duration of storing data. The duration of data storage is in line with our insurance policy requirements.

Personal data is kept for 7 years following the last occasion of treatment. For minors (those under the age of 18), records will be kept for 7 years past the age of maturity (until they have reached 25).

How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site or page. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences. OT Neuro Ltd use traffic log cookies to identify which pages are being used. This helps us analyse data about webpage traffic and improve our website in order to tailor it to customer needs.
